**Yuriy Kolesnikov** has three higher educations: legal, economic and business education. Doctor of law, Associate Professor. Specialty "Law" - qualification "lawyer", specialty "Finance and credit" - qualification "economist", specialty "Management and corporate business administration" - qualification "MBA-Executive".

**Scientific and pedagogical activity:** the main place of work on a full-time basis in RSU (now SFEDU) from 01.09.1992 to the present as a teacher, senior teacher, then Associate Professor and currently; head of the Department of Financial law; in different years he worked in different Universities and colleges part-time: Professor, Department of administrative and office right, the North-Caucasian Academy of public service (now the South Russian Institute - branch of Russian Presidential Academy of national economy and public administration under the President of the Russian Federation), Professor of Constitutional and Administrative law of Moscow State University of Economics, statistics and Informatics "MESI".

Since 1992, he has been combining scientific and pedagogical activities with practical work in the financial sector, in the field of insurance, including from April 1993 he worked as General Director, and subsequently from August 2006 to September 2009-Chairman of the Board of Directors of the insurance company "ADMIRAL" (Rostov-on-Don), from October 2009 to September 2012 he was General Director-Chairman of the Board of the OSAO "Russia" (Moscow), currently; Chairman of the Supervisory Board of the leasing company "MSB-Leasing", co-founder and GR-Director of the operator of the investment platform "Money

Friends", managing partner of the Parliamentary center for business support and development "OPORA".

**Total number of published works:** 280, 5 of them are monographs.

**Actively engaged in social and expert activity:** he is a member of the Expert Council of the Duma Committee of the Russian Federation, member of the Scientific Advisory Board of the Supreme Court of the Russian Federation, which has been repeatedly marked by letters of thanks of the Supreme Court of the Russian Federation, a member of the Expert centre for regulation of control and Supervisory activities of the Russian public organization "Business Russia".
